**Audited Financial Statements**

The Directors present herewith their report and the audited financial statements for the year ended 31 March 2011. In preparing these financial statements, the Directors have exercised the options available to a small sized private company under the Companies (Amendment) Act, 1986.

**Principal Activity**

The organisation is involved in the provision, promotion and advancement of development education throughout the island of Ireland.

**Results**

The results for the year are set out in the Income and Expenditure account on page 5.

**Directors' Responsibilities**

**Auditors**



## Independent Auditors' Report to the Members of Irish Development Education Association (IDEA) Limited
